The candidates are strictly advised to apply online well in time, without waiting for the last date of submission of online application. No offline application form will be accepted by NIOS.

Candidates need to fill the form online carefully and upload his/her photograph, signature and other self attested certificates of educational qualifications and work experience, etc. Incomplete application or applications without the supporting documents will be summarily rejected and no communication will be made and entertained in this regard.
